If the Lessor detects a significant deterioration in the condition of the Device, which is beyond normal wear and tear and deterioration of the Device and beyond changes that accompany the contractual use of the Device, the Lessor has the right to demand compensation from the Customer for the costs of repairing the Device. If repairing the Device is not practical or if the Device is lost during the Lessee's use or if the Customer does not allow the return of the Device within three (3) months after the end of the Contract, the Lessor may demand compensation for the residual value of the Device. The residual value of the Device is calculated on the basis of Tables 2.1 and 2.2 based on the cost of the Device indicated in Table 2.

The costs of the Standard Installation of the Device are included in the Rental Fee and are not subject to separate payment if the Lessee uses the Device for at least five (5) years (for an air-to-air heat pump), at least nine (9) years (for an air-to-water heat pump). If the Lessee terminates the Contract after the installation of the Device, but before five (5) years (for an air-to-air heat pump), nine (9) years (for an air-to-water heat pump) from the conclusion of the Contract, the Lessee is obliged to pay the Lessor the residual value of the Standard Installation of the Device, unless the reason for the cancellation is a significant breach of the Contract by the Lessor. The residual value of the Standard Installation costs is calculated on the basis of Tables 3.1 and 3.2 based on the cost of the Standard Installation indicated in Table 3. The year of use of the Device starts from the day of installation of the Device.
