

## Enefit OÜ fixed electricity package campaign, March 2026

From 2 March to 31 March 2026, Enefit OÜ will run a customer campaign in which all customers who have signed up for a fixed electricity package Fixed 6, Fixed 12 or Fixed 36 will participate in a prize draw for 20 electricity bill compensations of €50 each. The draw will take place on 15 April 2026.

Campaign terms and conditions:

1. The campaign is organised by Enefit OÜ (hereinafter: *Enefit*), registry code 11184032, registered address Lelle 22, 11318 Tallinn (hereinafter: **campaign organiser**); phone 777 4040, email [teenindus@enefit.ee](mailto:teenindus@enefit.ee).
2. The campaign will run from 2 March 2026 to 31 March 2026.
3. The campaign is carried out in the Republic of Estonia.
4. The campaign organiser establishes the procedure for conducting the campaign in these rules. All decisions made by the campaign organiser during the campaign are final and binding on all participants.
5. The total prize fund for the campaign is €1000.
6. As part of the campaign, twenty (20) winners will be drawn from all participants, each of whom will receive compensation for their Enefit electricity bill(s) worth €50 (fifty euros) (hereinafter: **prize**).
7. All customers who, as of 31 March 2026, have entered into a fixed electricity package Fixed 6, Fixed 12 or Fixed 36, for which the withdrawal period has expired, and who have registered to participate in the prize draw on the [enefit.ee/kindel](https://enefit.ee/kindel) or [enefit.ee/fiks](https://enefit.ee/fiks) webpage, or have used the promotional code #fiks or #kindel when concluding the contract, participate in the campaign.
8. Only persons who have no outstanding claims or other debts towards the campaign organiser are entitled to participate in the campaign. The organiser has the right to verify the absence of any outstanding debts of a participant before permitting participation in the campaign and/or before awarding the prize. If it becomes apparent that a participant has any outstanding debts towards the campaign organiser, the organiser has the right to exclude the person from the campaign and/or to withhold the prize.
9. The winners of the campaign will be drawn by the campaign organiser on 15 April 2026.
10. The winners of the campaign are drawn by the campaign organiser using a random generator (random.org application).
11. Each customer can win only once. If the same participant is drawn more than once, the prize will be redrawn and awarded to a new participant.
12. The prize is awarded no later than 30 days after the end of the campaign.
13. The winner will be contacted personally for the awarding of the prize.
14. If the winner cannot be contacted within 30 days after the end of the campaign, the campaign organiser reserves the right to withhold the prize.
15. The prize is applied to the electricity bill, and any unused prize amount is carried forward to subsequent months until it is fully used. The value of the prize will not be paid out in cash (including upon termination of the service) or exchanged for any other item or service.
16. The campaign organiser assumes all responsibility for fulfilling all legal obligations related to the awarding of prizes.
17. The campaign organiser reserves the right to make changes or clarifications to the campaign terms and conditions and/or to cancel the campaign, with campaign participants being notified immediately on the homepage of the campaign organiser: [www.enefit.ee/kindel](https://www.enefit.ee/kindel) and [www.enefit.ee/fiks](https://www.enefit.ee/fiks). Any changes, clarifications and/or the cancellation of the campaign are

deemed communicated to the participants from the moment the relevant notice is posted on the homepage of the campaign organiser.
